**SECOND SUPPLEMENTAL ORDER OF REAPPOINTMENT OF
COUNSEL TO THE CJA PANEL FOR THE THREE-YEAR TERM
OF JULY 1, 2006 THROUGH JUNE 30, 2009**

Section 1.04(c)(2) of the Criminal Justice Act (CJA) Plan for the Middle District of Florida, issued by the undersigned on April 30, 2004, and approved by the Judicial Council of the United States, Eleventh Judicial Circuit, on July 6, 2004, provides for panel attorneys to meet certain minimum qualification standards.


